Location

Kiln House is situated on the north side of Pottergate in the centre of Norwich.

The city centre's numerous leisure and retail amenities are within a short walk, as is the St Giles Street multistorey car park.

A short distance to the west is the inner ring road, which provides access to the A11 and Norwich mainline railway station where there are two services per hour to London Liverpool Street.

Description

Kiln House is a well known multi-occupied building providing functional office space over six floors.

There is a staffed reception off Pottergate with male & female WCs in the core areas, along with two passenger lifts. Level 4 is at second floor level above the main entrance. It provides mostly open plan space with some offices created out of demountable partitioning.

The specification includes comfort cooling, carpets, floor boxes, and suspended ceilings with recessed lighting.
